<b>DESCRIPTION AND LOCATION</b>	Built by Jack Resnick & Sons in 1962 and 1968, this distinctive 18-story tower was designed by Herbert Tannenbaum. The building underwent a major renovation in 2009, including a distinctive double-height stone and glass lobby with 2-story retail storefronts, a new aluminum curtain wall system, new windows, new cooling tower and a modernized elevator system with new cabs. The striking redevelopment was designed by MdeAS Architects.
<b>LOBBY</b>	Redesigned lobby and storefronts featuring Italian Verde granite floors and Danby Vermont marble and glass finishes with a 2-story entrance. Featured artwork "Mega Flux and the Bodies of Perception" by Lydia Donna, 1999-2000.

<b>CEILING HEIGHTS</b>	11'4" slab-to-slab
<b>ELEVATORS</b>	Modernized elevators (2011). Two (2) passenger elevators: Lobby - 18th floor - 2,500 lbs. cap. One (1) passenger elevator: Basement - 18th floor - 3,000 lbs. cap.
<b>EMERGENCY POWER</b>	A new 240-kW diesel fuel oil generator provides back-up power to all fire, life safety and critical systems (2019).
<b>SECURITY</b>	24/7 attended lobby; electronic access system; web-based visitor pass system. All common areas and exterior of building are monitored by CCTV cameras.
<b>BASE BUILDING HVAC</b>	Central plant consists of one (1) 600-ton capacity cooling tower (installed 2008) and one (1) 380-ton chiller (installed 2012) providing chilled water to central interior air handlers and perimeter fan coil units. Heat is provided by steam to interior air handlers and steam/hot water converter to perimeter induction units.
<b>SUPPLEMENTAL HVAC</b>	Condenser water is available for tenant supplemental air conditioning
<b>ELECTRICAL</b>	Six (6) watts per usable SF connected load available for tenant use.
<b>BUILDING MANAGEMENT SYSTEM</b>	Andover BMS system (2011). Mycor Energy Management Platform installed 2018.
<b>LIFE SAFETY</b>	Class-E Fire Alarm System. Building fully sprinklered.
<b>TELECOM</b>	WiredScore Gold Certified - Crown Castle, Spectrum Business, Spectrum Enterprise Stealth, Verizon, Zayo Group (Please see Telecommunications Factsheet for more details)
<b>TRANSPORTATION</b>	Adjacent to 6, E & M subways, surface transit and Citibike.
